The warranties do not cover installed visual defects. Once the carpet is installed, no warranty coverage will be provided for defects in the carpet which are clearly visible and should have been discovered prior to installation.

The warranties do not cover improper cleaning and maintenance or inadequate care. All of the warranties are conditional and require routine cleaning and maintenance with hot water extractions by a carpet care professional at a minimum of every 18 months. Likewise, improper installation and damage from improper installation is not covered by the warranties.

Gulistan recommends a new pad with a minimum thickness of 7/16 inch for optimum performance. Warranties are voided if you fail to follow recommended carpet care and routine maintenance of the product or recommended installations guidelines.

Odors, padding failures, outdoor installations, carpet installed with a present moisture problem are not covered in the warranties.

Shading (also called watermarking, pooling) is not a carpet defect and is present to some degree on most all cut pile carpets. There is no known cause for this phenomenon and this effect is not covered under any of the warranties.

The Gulistan warranties are offered exclusively to the original homeowner. The warranties are not transferable.

- ✓ Use a quality carpet pad of the correct thickness.

GULISTAN LIMITED LIABILITY

If you have complied with the Homeowners Installation and Maintenance Obligations spelled out in this brochure, Gulistan will have as its entire liability and exclusive remedy the warranty liability described in this section. Gulistan's liability under this limited warranty shall be limited to the actual cost of repair or replacement (of carpet) of only the affected area of carpet extending to the closest wall, doorway, or entrance.

Gulistan reserves the right to correct any defect prior to carpet being removed, replaced or any settlement being offered. Upon validation of the claim and that the carpet cannot be restored by repair, Gulistan will arrange credit to your retailer equal to a percentage of the cost of the carpet only. Credit will be issued based on the length of time the carpet has been in use and according to the proration schedule set out below for the identical (or if identical carpet is not available, comparable) carpet of equal value. The credit will be good only toward the purchase of new Gulistan carpet. There will be no cash payment.

Gulistan will not be liable for or will not pay consequential, incidental, or special damages of any kind whatsoever under this warranty. Some states do not permit exclusions or limitation of incidental or consequential damages, so the exclusion of limitation may not apply to you.

- To qualify for coverage under the Gulistan limited warranties outlined in this brochure, you must have had a hot water extraction cleaning performed by a trained, qualified carpet care professional, at least as frequently as every 18 months since the date of your carpet purchase. Failing to do so will void your warranty coverage.

Color-Lock Limited Lifetime Fade Resistance Warranty - Gulistan warrants that this carpet will not show a permanent color change due to exposure to sunlight greater than one unit as measured by the AATCC Gray Scale for standard comparison of the extent of color differences for the life of the carpet.

If, within the warranty period, a color change due to atmospheric contaminants should exceed the AATCC Gray Scale criterion, Gulistan will handle the claims as stated in the Gulistan Limited Liability section of this warranty brochure.

The items listed in the "Carpet Warranty and Carpet Characteristic Exclusions" sections of this brochure

Color-Lock Stain Resistance Limited Lifetime Warranty - Gulistan warrants the surface pile of this carpet will resist stains by most common household foods and beverages for the life of the carpet from the original date of installation. If permanent staining should occur that cannot be removed using recommended methods by a certified carpet-care professional, your claim will be handled by Scotchgard by 3M. To file a claim, please call 800-433-3296. Claims filed after 10 years of the date of installation will be handled by Gulistan in accordance with the Gulistan Limited Liability section of this warranty brochure.

Not Covered:

In addition to the warranty exclusions listed in the "Carpet Warranty and Carpet Characteristic Exclusions" sections of this brochure, also specifically excluded from this warranty is damage or residual stains caused by non-food and non-beverage substances, that contain strongly colored natural disperse dyes as found, for example, in mustard, coffee, herbal tea, red wine and hot beverages. as well as, substances which destroy or change the color of carpets such as bleaches, acne medication, drain cleaners, plant food, vomit, urine other than pet (domestic dog or cat) urine and feces.

Color-Lock Pet Stain Resistance Limited Warranty - Gulistan warrants that the surface pile of this carpet will resist stains from all domestic pets, including vomit, urine, and feces, for the life of the carpet from the original date of installation. If the abovementioned stains are saturated and result in wicking, these stains will release with additional recleaning for the life of the carpet. (wicking is defined as a reappearance of previously cleaned stains due to liquid remaining in the carpet backing of padding). If permanent staining should occur that cannot be removed using recommended methods by a certified professional, Gulistan will handle such claims as stated in the Limited Liability section of this brochure.

Not Covered:

In addition to the warranty exclusions listed in the "Carpet Warranty and Carpet Characteristic Exclusions" sections of this brochure, also specifically excluded from this warranty is damage or stains caused by any vomit, urine, or feces other than domestic pets (dogs and cats).

Color-Lock Soil Resistance 15 Year Limited Warranty – Gulistan warrants that this carpet will not have a noticeable color change due to deposits of dry soil resulting from normal, indoor household foot traffic for the term of this warranty from the original date of installation. "Noticeable color change" is defined as a rating of less than 3 using standardized rating scale (Gray Scale American Association of Textile Chemist and Colorists Evaluation Procedure 1 or equivalent in the US). If permanent staining should occur that cannot be removed using recommended methods by a certified carpet-care professional, your claim will be handled by Scotchgard by 3M. To file a claim, please call 800-433-3296. Claims filed after 10 years of the date of installation will be handled by Gulistan in accordance with the Gulistan Limited Liability section of this warranty brochure.

Not Covered:

In addition to the warranty exclusions listed in the "Carpet Warranty and Carpet Characteristic Exclusions" sections of this brochure, also specifically excluded from this warranty is damage or color changes caused by grease, mud, asphalt, tar, paint, ink, rust, blood, cement, urine, feces, vomit; or from materials that permanently destroy dyes or alter colors (such as bleaches, acne medications, drain cleaners, and plant food); or change in appearance or color due to burns, pets, tears, cuts, pulls, shading or pile reversal, fading, furniture depressions or athletic equipment.

Color-Lock Texture Retention 15 Year Limited Warranty

- Gulistan warrants this carpet will maintain its texture retention, not showing excessive pile crushing or matting from ordinary foot traffic as a result of the tufts losing twist, for a period of 15 years from the original date of installation. "Texture retention" is the ability of the carpet tufts to retain their visible shape, as measured by the degree of bursting, opening, or untwisting of the tufts at the surface of the carpet. Texture retention is measured against standardized rating scales ranging from 5.0 (new or no change) to .0 (severe change), ISO Standard 9405-1990. To perform as warranted, this carpet must retain a texture rating of at least 2.5 under warranted conditions. If within the warranty period, a texture rating of less than 2.5 occurs under the warrantied condition. Gulistan will handle the claim such as stated in the Gulistan Limited Liability section of this brochure.

Not covered:

The items listed in the "Carpet Warranty and Carpet Characteristic Exclusions" sections of this brochure.

Color-Lock Manufacturing Defect 15 Year Limited Warranty

- Gulistan warrants that this residential carpeting against manufacturing defects for a period of 15 years from the original date of installation. If within the warranted period. this carpet determined to be defective, Gulistan will handle the claim as stated in the Gulistan Limited Liability section of this claim section of this brochure.

Not Covered:

The items listed in the "Carpet Warranty and Carpet Characteristic Exclusions" sections of this brochure.

CARPET WARRANTY AND CARPET CHARACTERISTIC **EXCLUSIONS**

These warranties specifically exclude any carpet that has been treated after installation with any foreign agents. non-residential installations, abnormal abuse, and carpet exposed to hot substances or other abusive conditions that deteriorate the appearance of the pile fibers. Specifically excluded from this warranty is crushing caused by furniture and damage caused by tears, pulls, burns, wheel traffic, or athletic equipment.

Also excluded is carpet installed in kitchens, bathrooms, laundry rooms, stairs, carpets in commercial facilities, and outdoor areas. These warranties do not cover water damage from plumbing or appliance failure, storms, or flooding.

The Gulistan warranties do not cover stains incurred by or resulting from commercial use (i.e. contracted services, in-home businesses, etc.) or anywhere other than owner occupied residences. Only single family, owner occupied indoor residential installations are warrantied.
